

(All Sports)



#### **APR Trends in Baseball, Basketball and Football**



#### Eligibility Trends in Baseball, Basketball and Football



### **APR Delayed Graduation Points**



#### **Total Number of Delayed Graduation Points**

- ► In the past 21 years, 21,977 student-athletes have earned APR points for their former team by returning to college after their eligibility expired and completing their degree.
- Among high-profile sports, delayed graduation points total:

Football: 6,428

Baseball: 2,416

Men's Basketball: 1,657

Women's Basketball: 761

In other words, over 11,000 former student-athletes in these four high-profile sports returned to college and graduated, earning their former team APR points. Note that these student-athletes are <u>not</u> typically counted as graduates in the calculation of the federal graduation rate or the GSR.

#### Number of Teams Below APR Penalty / Access to Postseason Benchmark

- 49 teams with three or more years of data had an APR below 930 in 2024.
- The majority of teams below 930 are from schools defined as:
  - Limited Resource Institutions (76%)
  - FCS Subdivision (61%)
  - ► Historically Black Colleges and Universities (49%)
- ▶ While the number of teams below 930 remains less than 1% of all Division I teams, those below the benchmark are concentrated at schools defined as limited-resource, FCS subdivision and/or HBCUs.








